Re: Novavax XBB.1.5 COVID-19 Vaccine Availability, Collaborative Vaccine Redistribution and Updated Respiratory Illness Screening Resources

Novavax XBB.1.5 COVID-19 Vaccine

The Novavax XBB.1.5 COVID-19 vaccine was approved by Health Canada on December 5, 2023 and is now available in Manitoba. The Novavax vaccine is indicated for individuals 12 years of age and older. It can be offered as an alternative to individuals who are unable or unwilling to receive the preferentially recommended mRNA COVID vaccines.

To request doses of the Novavax XBB.1.5 COVID-19 vaccine, please send an email to vaccines@gov.mb.ca with your order details. Additionally, please ensure that you include your Holding Point Code in the email when requesting doses for efficient processing of your order. Novavax XBB.1.5 is available in 5-dose vials.

Please be advised that there will be limited delivery opportunities the week of Dec 25-29, 2023 due to holiday closures.
